1. Meeting Call to Order

Dr. Diane Lovell, Vice Chancellor for Student Services, called the meeting to order at 10:00 a.m.

2. Approval of Minutes for the December 03, 2020, meeting

This committee previously approved the *Minutes* electronically on January 28, 2021 and posted to the website.

3. Academic Affairs Update

Dr. Marcelo Bussiki, Vice Chancellor for Academic Affairs, presented the Academic Affairs Update.

Fall 2021 classes will continue to offer parts of term, 4-, 8-, 12-, and 16-week classes. Blinn will offer the same modalities as before: face-to-face, fully online, and flex online. The only difference is that each of these three modalities will have a version that are asynchronous, done by Zoom for students that still do not feel comfortable coming on campus.

Procedures have been in place for Blinn College faculty credentialing but were not officially listed in the Administrative Regulations. Procedures have been created and added to the Administrative Regulations.

Transfer Agreements – working on several MOUs/transfer agreements with Texas A&M Agricultural Sciences, Tarleton State University, Prairie View A&M University-Public Health (dual-enrollment), Texas A&M-College Education & Human Development, and Texas Tech University-Arts and Theater.

Dr. Hensley mentioned the Board would consider acceptance of the Districtwide Facilities Master Plan in May. The master plan identifies Waller County as an expansion opportunity. This could potentially allow Blinn College more course offerings in this area. The majority of Blinn students come from the Houston area.

4. Facilities Update

Mr. Richard O'Malley, Assistant Vice Chancellor for Facilities, Buildings, Planning, and Construction, and Mr. Mark Feldhake, Facilities Project Manager, presented on current building projects and plans for upcoming facilities at the STEI (science, technology, engineering, and innovation) building, P3 residential housing facility in Brenham, and the

Phase II Blinn building on the RELLIS Campus which will hold academics, esports, and student services. Dr. Hensley thanked both Mr. O'Malley and Mr. Feldhake on their work with the new buildings at the Brenham and RELLIS campuses.
