**DUE: Tuesday, 20 June 2017 by 12:00 p.m. Central Time. Late applications will not be accepted. Awards will be announced after 1 July 2017.**

T-STEM Scholarships at Blinn College were made possible from a grant provided to the Texas Higher Education Coordinating Board (THECB) from the Texas Guaranteed Student Loan Corporation. T-STEM Scholarships are merit scholarships, based on past and continued student performance in specific T-STEM instructional programs. Due to a change in funding, award amounts may be less than \$1,250/semester.

**Eligible Students receiving a first-time (initial) Blinn College T-STEM Scholarship must:**

- ✓ have graduated from high school with a least a 3.0 GPA on a four-point scale in mathematics and science courses;
- ✓ be enrolled at or planning to enroll at Blinn College and self-declared in a T-STEM\* instructional program; (\*See Scholarship Guidelines for a detailed listing of eligible programs). Preference will be given to students who are enrolled full-time.
- ✓ agree to work no more than 15 hours a week in their chosen instructional program area or related field, or for a business participating in the T-STEM Scholarship Program; and
- ✓ have a statement on file with Blinn College indicating that the student is registered with the Selective Service System as required by federal law or is exempted from Selective Service Registration under federal law.

**To qualify for a *renewal* of scholarship funds under the T-STEM program, a student must:**

- ✓ remain in a T-STEM instructional program;
- ✓ maintain an overall grade point average of at least 3.0;
- ✓ complete at least 80% of all attempted credit hours in each semester to retain his/her T-STEM Scholarship for the following semester;
- ✓ complete a minimum of 30 semester credit hours within a year (fall, spring, and summer semesters or equivalent); and
- ✓ work no more than 15 hours a week in their chosen instructional program area or related field, or for a business participating in the T-STEM Scholarship Program.

**For consideration of a T-STEM Scholarship, the following documentation must be provided to the Blinn College Office of Financial Aid:** Completed Application and a Final High School Transcript (initial scholarship applicants only) showing a minimum 3.0 in Math and Sciences Courses (to be verified).

### Reference: Statutory Program Restrictions

- (1) Received a certificate of discharge by the Texas Department of Criminal Justice or a correctional facility or completed a period of probation ordered by a court, and at least two years have elapsed from the date of receipt or completion; or
- (2) Been pardoned, had the record of the offense expunged from the person’s record, or otherwise has been released from the resulting ineligibility to receive a grant under this subchapter.”
