ENTRY FORMS

ACADEMICS AND ONE-ACT PLAY

With the new UIL Spring Meet Entry Management System, district meet academic directors will certify one-act play and academic results online. This will serve as each district's official entry form. Upon certification, the regional meet director will advance the qualified entries online.

ATHLETICS: GOLF

The District Meet Results form will serve as the official entry form for Golf. No additional forms are needed from the schools within a district. Each District Director General is responsible for sending the results to the Regional Meet site immediately following the District Athletic Meet. Results should be faxed or e-mailed immediately; originals must be mailed to the Regional Golf Director listed below.

ELIGIBILITY

The eligibility of each student competing at the Regional Meet is the responsibility of the individual school he or she is representing.

FEES

OVERVIEW

In order to simplify the accounting procedure for the Regional Meets entry fees, the Spring Meet District Director for each district represented in the region should send **two** checks, one check for the total entry fees for the academic events, including One-Act Play, and one check for the total entry fees for the golf events. The Spring Meet District Chairperson may then assess each member school in the UIL district according to each school's number of contestants.

DEADLINES

Academics postmarked by **21 April 2009**
One-Act Play postmarked by **21 April 2009**
Golf postmarked by **15 April 2009**

All entry fees must be paid before participants can compete.

Each District Director must certify the district results. The correct and full names, not initials, of the contestants must be given. The first and second alternates must be notified that if one or two of the qualifiers cannot make the Meet, the alternate(s) will be able to compete at the Regional Meet. If a school has any changes in its entries after they have been submitted, **both** the District Director and the Regional Meet Director must be informed prior to the day of the contest. Any team substitute, as allowed by the *C&CR*, must present a completed substitution form or a letter of eligibility signed by the designated school administrator.

ACADEMIC EVENTS FEES

FULL SLATE: \$1400.00

Each District Meet Chairperson handles all entry fees for his or her district and then bills respective high schools for the amount owed. The Chairperson should send the academic fees and One-Act Play fees once all pre-region competition has been certified. The check should be made to cover both the full academic slate and the O-AP fees for the district's advancing plays. (See deadlines above.)

* Each UIL district sends—on average—90 students to the regional meet, depending on team numbers and wild cards (not including One-Act Play). Depending on this number, the District Meet Chairperson should reckon the entry fee for each contest seat at approximately \$16.00 (not including O-AP.)

ONE-ACT PLAY FEES

A \$250 entry fee is required of each one-act play entered in the One-Act Play Competition. Each school with a play advancing from area to regional should send its One-Act Eligibility Notice to the Regional Contest Director, Mr. Brad Nies, Blinn College, on the next business day following the posting of the results of the Area Contest.

Note: Admission for the One-Act Play Contest is \$1.00 for students and \$2.00 for adults; however, individual members of the cast and crew will not be required to pay the cost of general admission to watch the other plays in the competition.

GOLF FEES

Each contestant is required to pay \$45.00, which covers both the entry fee and the greens fees for the contest itself. This should be sent to the District Director for the district, along with a list of players. This procedure is different from last year's.

Practice round fees and range balls fees are paid directly to Brenham Country Club.
